CFSI AWARDS AND RECOGNITIONS for the year 2022

Applications are invited for awards and recognitions of Coldwater Fisheries Society of India from the scientists, academicians, researchers, entrepreneurs and farmers for year 2022, on the occasion of National symposium on "Fisheries and Aquaculture for livelihood and nutritional security" to be organized jointly by ICAR-DCFR and CFSI during 18-19 November 2022 at Bhimtal.

The categories of Awards are as follows;

(1) Dr. K. L. Sehgal Award - 1 No.

Eligibility: In order to recognize the significant contribution of the Eminent Fisheries Scientist/Academician/ Aquapreneurs in the field of coldwater fisheries research and development in India, this award is conferred on annual basis. Name of the awardee will be selected by the executive committee of the society on the basis of the significant contribution for the coldwater fisheries sector. The award carries a cash prize of Rs. 10000/- along with a certificate and a memento.

(2) Dr. P. C. Mahanta Award - 1 No.

Eligibility: This award is conferred to the one innovative fish farmer for the outstanding performance in coldwater aquaculture practice. Name of the awardee will be selected by the executive committee of the society among the applicants, submitted by state fisheries departments/KVK/Scientist working in the field/others. The award carries a cash prize of Rs. 5000/- along with a certificate and memento. (Application-A)

(3) CFSI Fellowship - 2 Nos.

Eligibility: Any fisheries scientist/academician involved in fisheries and has made significant contribution in the field of coldwater fisheries research and development in India is eligible for fellowship. Name of the awardee will be selected by the executive committee of the society among the applicants. The award carries a certificate and memento. (Application-B)

(4) CFSI Gold Medal - 2 Nos.

Eligibility: Any fisheries scientist/academician having significant contribution in the field of coldwater fisheries research and development is eligible for this award. Name of the awardee will be selected by the executive committee of the society among the applicants. The award carries a certificate and memento. (Application-C)

(5) Dr. S. S. Gupta Memorial Award for the young scientist - 1 Nos.

Eligibility: Any fisheries scientist/academician (age below 40 years) having significant contribution in the field of coldwater fisheries research and development is eligible for this award. Name of the awardee will be selected by the executive committee of the society among the applicants. The award carries a medal and certificate. (Application-D)

(6) CFSI Women Scientist Award - 1 Nos.

Eligibility: Any women fisheries scientist/academician having significant contribution in the field of coldwater fisheries research and development is eligible for this award. Name of the awardee will be selected by the executive committee of the society among the applicants. The award carries a medal and certificate. (Application-E)

(7) Young Scientist Award - 3 Nos.
Eligibility: Any young fisheries scientist/academician (age below 40 years) is eligible for this award. Name of the awardees will be selected by the constituted evaluation committee among the applicants. Selection is purely on the basis of paper presentation before the committee. The award carries a medal and certificate. (Application-F)

(8) Best Poster Presentation Award - 3 Nos.

Eligibility: Any young fisheries scientist/academician (age below 40 years) is eligible for this award. Name of the awardees will be selected by the constituted evaluation committee among the applicants. Selection is purely on the basis of poster presentation before the committee. The award carries a medal and certificate. (Application-G)

It is to be noted that all the applicants for the above mentioned awards should essentially be a Life Member of CFSI, c/o ICAR-DCFR, Bhimtal during the time of applying for the Awards and Recognitions.

The persons who have received this award previously are not eligible to apply again in the same category.
